**REGULATIONS**

**1. Introductory Provisions**

**Name of the Festival:**

International children's and youth radio drama festival "PRIX EX AEQUO 2022" (hereinafter referred to as "Festival").

**Form of the Festival:**

Public competition in accordance with § 847 of the Civil Code as amended.

**Aims of the Festival:**

- to promote creation of works of art in the field of radio drama for children and youth;
- to promote the international exchange of radio drama for children and youth (production, texts, artists);
- to promote exchange of theoretical, technical and professional expertise at the international level in the field of creation of radio drama works for children and youth.

**Organizer:**

The Festival is organized by Radio and Television Slovakia with the seat at Mlynská dolina, 845 45 Bratislava, in cooperation with the European Broadcasting Union (EBU).

**Partners of the Festival:**

- Trnava University in Trnava
- the Faculty of Education of Comenius University in Bratislava.

**Basic information:**

The Festival is a public competition according to § 847 of the Civil Code as amended and an international competition for children's and youth radio plays.

The Festival is open to Members and Associates of the EBU.

Eligible for the Festival are radio drama programmes for children and youth.

The Festival takes place from 8 to 11 November 2022.

Venue of the Festival is Radio and Television Slovakia, Bratislava, Slovak Republic. Side events take place on the premises of the partners of the festival.

The official language of the Festival is English.

There are 2 following competition categories:

- a radio fairy tale for children
- a radio play for youth

In case of an adverse epidemic situation the Festival might be held in an online form.

## **2. General Provisions**

### **Programmes submitted:**

Participating organizations may submit drama programmes complying with the criteria of the Regulations and first produced in the period from September 2020 to the end of August 2022.

Each radio organization may submit drama programmes for each category. The total duration of the programme in one category may not exceed 60 minutes.

### **Technical standards:**

Participating organizations will send to the organizer of the Festival the following materials **by 15 September 2022 at the latest:**

### **Jury:**

The international Jury in both categories has 3 members.

The Jury is set up of experts in radio drama and literature for children and youth.

Radio and Television Slovakia appoints an expert from its own country to the Jury in each category. Two additional Jury members are appointed by Radio and Television Slovakia on the basis of EBU Members' proposals.

The members of the Jury cannot personally be involved in the programmes submitted to the competition. Each Jury will elect its own chairman from its members.

After having listened to all competing programmes the members of the Jury will shortlist 5 best titles of each category and on the basis of this shortlist they will define the winner for each category. In case of equality of votes the Jury chairman shall decide on the prize. The evaluation criteria of the competing contributions are artistic and technical elaborations as well as other criteria at the Jury's discretion.

### **Prizes:**

The Jury shall award in each category the following prizes:

- a prize for overall quality in each category to an *organization* submitting its entry to the competition:

- **PRIX EX AEQUO for the best radio fairy tale for children**
- **PRIX EX AEQUO for the best radio play for youth**

- a prize in each category to an *individual*, engaged in the competing programme:

- **PRIX EX AEQUO for the exceptional execution** of radio fairy tale for children
- **PRIX EX AEQUO for the exceptional execution** of radio play for youth

The PRIX EX AEQUO prizes are of non-financial nature. The prizes will be provided and financed by Radio and Television Slovakia and will be handed over by the Director of the Festival on 11 November 2022 at the award ceremony that will be broadcast live at Radio Devín channel. There is an information embargo until the official announcement of the winners.

### **Tax regulations:**

Prizes of non-financial nature that do not exceed the sum of 350 EUR are exempted from tax in accordance with point m) of § 9 (2) of the Act No. 595/2003 Coll. (Income Tax Act) as amended.

### **Delegates, observers, press:**

Delegates, observers and press are allowed to attend the public listening sessions, seminars and discussions held during the Festival.

### **Costs:**

All costs arising from the participation in the Festival (copyright and translation arrangements, postage as well as accommodation, travel and subsistence costs of participants or other possible costs) will be borne by each organization or individual taking part in the Festival.

The Jury's costs for travel and accommodation during the Festival will be covered by Radio and Television Slovakia.

## **3. Final Provisions**

### **Changes and amendments to the regulations:**

No changes are allowed to the Regulations after their entering into effect and respective publication. The Organizer reserves the right to cancel the event.

### **Miscellaneous provisions:**

The fulfilment according to these Regulations cannot be transferred to any third party. Should any doubt occur regarding the fulfilment of the Regulations, the Organizer shall decide.

By submitting the entry the participant grants to the controller Radio and Television Slovakia, Mlynská dolina, 845 45 Bratislava, Registered No.:47 232 480 (hereinafter referred to as “controller”) pursuant to point a) of Article 6 (1) and Article 7 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) its consent to process its personal data for the following purpose: evaluation of the competition, keeping a record of the competition participants, mutual communication with the participants and sending information about the competition to the participants. This consent to the processing of personal data is a freely given, specific, informed and unambiguous affirmative act demonstrating participant’s agreement with the processing of its personal data to be granted until 30 November 2022. The personal data of participants will be mechanically discarded (shredded) after the given period of time and will not be processed in any other database. The Organizer of the competition shall not be liable for any eventual breach of the Act No. 185/2015 Coll. (Copyright Act) on the part of competitors.

#### **Validity of the regulations:**

The Regulations enter into force on the day of their signature by the Director General of Radio and Television Slovakia and into effect on the day of their publication. The Regulations expire on 30 November 2022.
